

The Interamerican Cooperative Institute




Founded by Fr. Harvey Steele in Panama in 1964, the institute offers training in cooperatives to lay community leaders in Latin America, with a goal of educating and providing locals with the tools required to deal with socio-economic problems. Here is the original building of the Institute.



Bishop Kenneth Turner arrived on the island of St. Lucia in 1964, working as pastor of the Our Lady of Fatima parish in La Clery (pictured here in 1972). The mission was interwoven with that of the St. Vincent mission and closed in 1989.

In 1967, he is ordained the first Bishop of the Prelacy of Itacoatiara.




Fourth General Chapter, July to August 1968

The Chapter is held in the Society's 50th year and has the largest contingent of delegates of members serving in the missions. New guidelines are drawn up to update the Society in light of Vatican II and to meet the challenges of a rapidly changing world.







Laity in Mission

- 1968: General Chapter asks the new Council to investigate accepting lay people as members of the Society.
- 1974: Chapter agrees to experiment with lay membership.
- 1987: The Department of Lay Association (DLA) is established.
- 1993: The DLA becomes the Lay Mission Office.

- The Formation-Education Department is established to train both lay and priest missioners.






In 1976, Fr. John Walsh is appointed associate director of the Ecumenical Forum.

- Calls for the establishment of an office which would be responsible for Society commitments in the areas of justice and peace.




Return to Mission in China



Resulting from the sixth General Chapter, the Justice and Peace Office is established in May 1980. Fr. Timothy Ryan is its first Director.




In 1981, Fr. Joseph Curcio goes to Guinea-Bissau for one year to do pastoral work.






Inspired by Scarboro's felt need for renewed dynamism, the entire Society membership is invited to attend the Assembly.


